

Student will be encouraged to take advantage of the opportunities that exist at ACOP for employment. Participation in programs that are allows students to gain valuable experience and training as interns will be encouraged. However, ACOP will have obligation to hire the student interns from NIPP.

FINANCE:

Regarding financial arrangements during the Community Pharmacist Training; there is no remuneration will be given to trainee student.

DURATION:

This arrangement will take effect from the date of its signing and shall be valid for 5 years from that date unless sooner terminated, revoked of modified by mutual written arrangement between the parties and may be extended by mutual written agreement.

TERMINATION:

Either party may terminate the agreement at any time during the term by provision of 03 months written notice to the other party.
